4. Tag that is considered to be illegal in XML is <.document >.

Hence, the correct option is (A).

10. In HTML, there's no problem if you omit the quotes around attribute values.

However, XML processors would refuse such an element because omitting the quotation marks around the

attribute value, is a violation of well-formedness, so option b is not correct and c, d has the back slash within quotes so they are also not correct.

Hence, the correct option is (A).

14. HTTP stands for HyperText Transfer Protocol. This protocol is used between client and server, where client is usually a browser. Text remains same across the network in the form of ASCII.

- 7. Parameter entities can only occur in the document type declaration. A parameter entity is identified by placing "%" in front of its name in the declaration.

- **8.** XML documents whose syntax has been checked successfully are called valid documents. In particular, an XML document is considered valid if there is a document type definition (DTD) or XML schema associated

- with it and if the document complies with the DTD or schema.
